93.3 THE BULL'S "MATTS BRAIN BUSTER " CONTEST OFFICIAL RULES

Eligibility. On-Air: Listen to the Station weekdays during the Contest Period. When the Station ask the "Brain Buster" trivia question listeners must call the Station at 801-570-9393. Starting with caller #1 the station will take calls until the correct answer is given. Once the correct answer is received that caller will be deemed the winner and notified on that call. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
