THE BULL "ZACH BRYAN" CONTEST OFFICIAL RULES

The Station will conduct the **THE BULL "ZACH BRYAN" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 2. Contest Period. The Contest entry period will begin at 1:00pm MT on August 28, 2023, and will run through 10:00am MT on December 4, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

Online: Visit the Station's website www.933thebull.com during the Contest Period, click on the "Contest" link, click on the "Shania_" Contest link, and complete an entry form. All entries must be received by 9:59am MT on December 4, 2024 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. 4. **Winner Selection.** On or about 8am MT on December 4, 2024, Station will select One (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period.

The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within Twenty Four (24) hours of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
