93.3 THE BULL'S "MATTS BRAIN BUSTER" CONTEST OFFICIAL RULES

The Station will conduct the **93.3 THE BULL'S "BRAIN BUSTER" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - <u>On-Air</u>: Listen to the Station weekdays during the Contest Period. When the Station ask the "Brain Buster" trivia question listeners must call the Station at 801-570-9393. Starting with caller #1 the station will take calls until the correct answer is given. Once the correct answer is received that caller will be deemed the winner and notified on that call. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
